## Client responsibilities

- In order for you to take charge of your health it is important to pay attention to yourself. Note down your symptoms each week so that we can discuss them at a later date, and call me to report any symptoms that concern you. Good communication about what is going on for you will give you the best chance to succeed in health.
- Learn to view your symptoms without judgment.
- Please bring a check for payment on the day of your appointment. I don't process credit or debit cards, and prefer a check over cash. If there is an issue of financial difficulty, please phone me with your concerns prior to your appointment.
- I require 24 hours notice for rescheduling or canceling an appointment. In making an appointment, I've set aside time out of my schedule specifically for you. If you have not called 24 hours in advance, and you fail to show up for an appointment, there will be a charge in the amount of the follow-up fee.

## My service to you:

- You may call the clinic phone number (720 224 1373) between 8am and 8pm, M-F to discuss any aspect of your treatment. I do not charge for short phone calls and I encourage you to phone me with any questions so that you can feel comfortable about your treatment. Do not be discouraged if you reach my voice mail- I will call you back as soon as I can M-F, and at the earliest possible time on the Monday following, if you phone on the weekend. If it is a weekend and it is urgent, say "urgent" on your message I will call you back on the weekend as soon as I am able. Phone calls over 30 minutes will incur a fee. If you call on a weekend and it is not urgent, I will return your call as early as possible on the following Monday.
- For acute situations I can often give you advice about a Homeopathic remedy over the phone for the acute consultation fee. If there is an acute situation for which I feel I cannot advise you over the phone, I will try to arrange an urgent office visit with you (fee of \$25.00).
- If I am unavailable due to vacation, etc, there will be a message directing you to another Homeopath or Bowen therapist who can advise you.
- If I need to reschedule an appointment with you I will give you 24hrs notice.
- I will keep all of your records strictly confidential. Your identity will be kept confidential if I should need to consult another Homeopath or Health Professional for supervisory purposes or if all or part of your case is used in any way for teaching purposes.
